ORDINANCE NUMBER 2010-1

AN ORDINANCE CHANGING THE NAMES OF STREETS WITHIN THE CORPORATE LIMITS OF TAYLOR, MISSISSIPPI, AND ADOPTING A MAP OF SAID STREETS

WHEREAS, the streets in Taylor, Mississippi, have previously been designated by Lafayette County road numbers; and

WHEREAS, the Mayor and Board of Aldermen wish to change the names of the streets to better reflect the sense of community and quality of life in Taylor, Mississippi;

THEREFORE, be it ordained by the Mayor and Board of Aldermen of the Village of Taylor, Mississippi:

Section 1: Street Names

- a. County Road 303 will henceforth be known as Old Taylor Road
- b. County Road 343 will henceforth be known as Peddler Field Road
- c. County Road 338 will henceforth be known as 1st Street
- d. County Road 323 will henceforth be known as Depot Street
- e. County Road 341 will henceforth be known as Hurdle Lane
- f. County Road 336 will henceforth be known as Tin Can Alley
- g. County Road 3065/Highway 733 will henceforth be known as Main Street
- h. County Road 335 will henceforth be known as Cutoff Road
- i. County Road 3063 will henceforth be known as Yocona Wells Private Road
- j. Resin Drive will remain unchanged
- k. Studio Street will remain unchanged
- 1. Town Square Lane will remain unchanged
- m. Canvas Drive will remain unchanged
- n. Mosaic Drive will remain unchanged
- o. Easel Street will remain unchanged
- p. County Road 3068 will henceforth be known as Pear Tree Lane
- q. Highway 328 will henceforth be known as Cotton Road
- r. County Road 3013 will henceforth be known as Horne Lane
- s. County Road 337 will henceforth be known as Old River Road
- t. County Road 339 will henceforth be known as Tatum Lane


Section 2: Location

These street names shall apply to streets located within the corporate limits of the municipality of Taylor, Mississippi, described as follows:

Tract No. 1. Beginning at the Northeast corner of Section 26, T-9-S, R-4-W, Lafayette County, Mississippi. Run thence West, 5280 feet to a point; thence North, 1322.8 feet to a point; thence East, 5276.37 feet to a point; thence South, 1323.63 feet to the point of beginning.

Tract No. 2. Beginning at the Northeast corner of Section 26, T-9-S, R-4-W, Lafayette County, Mississippi. Run thence South, 2644.62 feet to a point; thence East, 6758.59 feet to an iron rod; thence South, 3968.08 feet to a point; thence West, 12,035.1 feet to a point; thence South, 1318.68 feet to a point; thence West, 1320.66 feet to a point; thence North, 9238.67 feet to a point; thence East, 1320.8 feet to a point; thence South, 1322.8 feet to a point; thence East, 5280 feet to the point of beginning.
