Be it remembered that the Mayor and Board of Aldermen of the Town of Taylor, Mississippi, met in a Regular Meeting at the Town Hall on this the first Tuesday, the sixth day of June, 2017, at 7:00 p.m., with the following officers and members present, constituting a legal quorum to-wit:

The meeting was called to order by Mayor Hamilton, and the following business was had and done to-wit:

**Adopt Agenda:** Alderman Bridges moved to adopt the meeting agenda; the motion was duly seconded by Alderman Covington and passed unanimously.

**Approve Prior Meeting Minutes:** Alderman Covington moved that the minutes for the May 2, 2017 meeting be approved; the motion was seconded by Alderman Bridges, and passed unanimously.

**Approve Current Claims Docket:** Alderman Kisner moved to approve the Docket of Claims dated June 6, 2017; the motion was duly seconded by Alderman Covington and passed unanimously.

Clerk Williams reported that a quarterly Planning Commission meeting was held May 30, 2017. The Planning Commission took action on Case 2017051101 – Application for Use Permitted on Appeal, Special Event – Outdoor Concert in Plein Air on August 19, 2017. The application was approved unanimously.

**2017 Election Report:** Clerk Williams stated that all of the Campaign Finance Pre-Election reports were filed on time. The June 6, 2017 Municipal General Election had taken place and the votes were being tabulated by the election commissioners.

**Old Business:** Mayor Hamilton reported that the appointments planning commissioners' term for Sue Cook and Edye Conkerton were incorrect. They had been appointed last year so the commissioners rotating off should have been Bill Beckwith and Anita Hibbs. The mayor recommended that Bill Beckwith be re-appointed and that Cindy Hale be appointed, each to a three year term ending April 30, 2020. Alderman Meacham moved that Bill Beckwith be re-appointed and that Cindy Hale be appointed as planning commissioners, each to a three year term ending April 30, 2020. Alderman Bridges seconded the motion and it carried unanimously.

**New Business:** Mayor Hamilton said that a change in Town Clerk duties and pay would begin next month. Clerk Williams will take care of town clerk functions and relinquish the planning and municipal clerk duties. The pay for those two functions will pay for a deputy clerk to train to take over as Clerk Williams' replacement by the end of the fiscal year, September 30, 2017.

July's normally scheduled board meeting would be on July 4, 2017. Alderman Covington moved that the July Mayor and Board of Aldermen Regular Monthly Meeting be changed to July 3, 2017 at 7:00 PM. Alderman Bridges seconded the motion and it passed unanimously.
