

**Town of Taylor Minutes of the Mayor and Board of Aldermen
Regular Monthly Meeting on April 3, 2018**

Be it remembered that the Mayor and Board of Aldermen of the Town of Taylor, Mississippi, met in a Regular Meeting at the Town Hall on this, the first Tuesday, the third day of April, 2018, at 7:00 p.m., with the following officers and members present, constituting a legal quorum to-wit:

Mayor Jim Hamilton; Aldermen: Tim Bridges, Courtney Covington; Lyn Roberts; Jimmie Willingham; Clerk Cindy Conrad; Administrative Assistant Richard Williams and citizen Justin Reid.

The meeting was called to order by Mayor Hamilton, and the following business was had and done to-wit:

Adopt Agenda: Alderman Roberts moved to adopt the meeting agenda; the motion was duly seconded by Alderman Willingham, and passed unanimously.

Approve Prior Meeting Minutes: Alderman Covington moved that the minutes for the March 6, 2018 meeting be approved; the motion was seconded by Alderman Bridges, and passed unanimously.

Approve Current Claims Docket: Mayor Hamilton noted that this is the first time that our Claim Docket showed over \$100,000 in our bank account. Alderman Willingham moved that the current claims docket be approved; the motion was seconded by Alderman Bridges, and passed unanimously.

Town Clerk's Report:

Clerk Conrad reported that there was no road work done during the month of March, 2018.

New Business: Discussion of Quotes for mowing street rights of way: Mayor Hamilton reported that two people responded to the newspaper ad for mowing quotes. Mr. Les Pollan of Pollan Lawn Service responded to the ad with his bid and Mr. J. D. Belk of Four Seasons Lawn and Property Mgmt. responded with a bid. Clerk Conrad and Administrative Assistant Williams met with Mr. Pollan and showed him the areas where mowing and trimming are required and asked that quotes be submitted by April 3, 2018. Mr. Pollan submitted his quote for three hundred and eighty five dollars (\$385) each mowing and Four Seasons submitted their quote for four hundred dollars (\$400) each mowing. Alderman Bridges moved that the quote from Pollan Lawn Services for three hundred and eighty five dollars (\$385) each mowing, be accepted. Alderman Roberts seconded the motion and it passed unanimously.
